 - Mr. Zhang mentioned that similar standardization is undergoing in China NC.
 - Mr. Ezaki said TC100 secretary needs to share this document with TC110 because this relates to TC110.
 - Mr. Fairhurst puts comment about brightness. It should be luminescence rather than brightness.
 - AGS recommends TC100 secretary to forward this document to TC110 secretary.

- AGS recommends Switzerland NC to change its membership from O to P for TC100.
- Mr. Ezaki noticed the change of TA1/TS from Mr. Hasebe to Mr. Sakuma.

- AGS recommends that SS5 encourage the Japanese NC to submit an NP on "drive monitoring technology" and include the results of discussions in SS5 and AGS.
- 8. AGS acknowledges the requirement for standardization of functional map and recommends that SS5 undertakes further study on the feasibility of standardization.
- AGS recommends that SS7 should issue a further call for membership and studies the standardization issues of robotics technology within the scope of TC 100.
- 10. AGS recommends that SS8 continues to collect additional use cases for stage 0 project on "use cases of wearable systems".
