AGS thanked German NC/DKE and Prof. Dr. Michael Silverberg for hosting AGS meeting and providing nice meeting facilities and refreshments.

Chairman asked Mr. Ezaki for acting AGS Secretary because Mr. Inokuchi didn't attend AGS meeting in person.

Chairman requested the roll call of attendees.

Chairman explained the scope of AGS by using document 100/AGS233er.
